The Course is designed to ensure that candidates are aware of the hazards involved in carrying out excavations particularly in relation to underground services. The course will provide candidates with the required skills to carry out suitable investigations.

Course Objectives:

To provide attendees with the required skills and knowledge to carry out appropriate investigations for underground services prior to commencing any operations where these services may be disturbed, this includes all excavating and road cutting operations.

Who Should Attend?

- Candidates aged 18+ with a valid Safe Pass Card.
- Possession of an Irish PPSN.
- Good understanding of written and spoken English (if not a SOLAS approved interpreter will be required)
- Have previous experience dealing with Location of Underground services.

Note: This course is for operatives who do not currently hold a CSCS ticket.
